The Sept. Cowboy matches were held last weekend, Aug. 31st & Sept. 1st. Friday set up went well with Carlsbad Kid (Karl Mayer), Dusty Dave (Dave Ingebright, a new CAS shooter shooting his 2nd match), and Jus Dan D (Dan DuPertius, who also designed and wrote the stages) joining me. The north-facing bays were being used by Mercer Island PD when I arrived, but they were finished and cleared out before our set-up start time of 3pm, and the range was in good shape. This being Labor Day weekend, we had a fairly light turnout for a nice summer weekend match, but we expected that. We had 18 shooters on Saturday, with one shooter shooting clean. And we had 17 shooters on Sunday, with two shooters, Lawbreaker (Tim Thibert) and me, Cedar County Sheriff shooting clean. There were no safety violations or DQ's, or problems of any kind (other than the kind caused in the mind of a shooter when the timer goes BEEEEP).

With four comps (2 Match Director and 2 Scorekeeper) we had 31 paid shooters for the weekend, and \$310.00 was turned into the Club.

Sam asked that the new policy be posted and take effect on January 1 instead of September 1



# Rifle and Pistol, Sam Hewlett:

Attendance this month has been average with 956 people using the range. 595 of which were members and 361 guests. Of the 361 guests 234 were paying customers which brought in a total of

\$4,454.10 to the club. We had a very successful Kids day this month (see Greg's report). The range is in good shape. We have a new part time employee at the rifle/pistol range who started the 14<sup>th</sup> of August his name is Paul Pellegrino. He will be taking Sam Cody's place while she is out on medical. We also lost Robert Wells this month. Robert was an active RSO during Kids day shoots and a frequent visitor to the range. We are looking forward to a busy September with hunting season coming up. Hopefully our attendance will be better than in years past. We will be hosting a hunter sight in event on the 28<sup>th</sup> and 29<sup>th</sup> of Sept. which will help new hunters get their rifles dialed in at reduced cost.

Steel Match at RFGC for August 11, 2019 had a total of 18 participants. There were 7 RFGC Members, 10 Non-Members, and 9 extra guns for the match. We had 26 guns for this match. We submitted \$181 to RFGC and had \$51.78 in expenses. There were no DQ's to report and the weather was pleasant with some sun shining in the afternoon.

According to some participants, there was a low attendance because people thought there was no longer going to be a match. So far, there is no one interested in stepping up as Steel Match Director. I will let the BOD know once that will happen. The most recent ASI Match was held on August 10, the weather was threatening rain in the morning so the Course of Fire was held to 4 Stages. There were 44 participants, which is down for our usual. The Washington State IDPA Championship was being held at FAS during this same time,

- 2. Hunter Sight In: Ken Wong reported that it is tentatively scheduled for Sept. 28-29, 10am-2pm on the rifle range. Have 3 volunteers, need a couple more. Will start advertising after I get final approval from the board.

3. Diana's proposal for general membership action bay use. The Acton Bay Committee discussion: We feel that the proposal has merit and would like to pursue it in the future. Items that need to be worked out are the hiring of a rangemaster, the creation of an orientation class and the Safety Officer staffing.

During practices and sanctioned matches, it is required to have one Safety Officer in each bay. In order to implement the proposal there would have to be a qualified RSO II in each bay where people would be shooting.

Weekends are not really an option since every Sunday and Saturday is in use except for the third Sunday after IDPA.

We could do it on a weekday afternoon, but again we need qualified RSO II's who will commit to be there.

Another thought: Would the range be open to allowing steel targets (rounds ones that hang on the rebar stands) on the pistol range at 25 and 50 yards?

Until the staffing issues are resolved we felt that encouraging participation in ASI would be a good alternative. It is for handguns only, but there is no minimum caliber and no drawing from the holster is required.

4. Unhealthy tree removal in the action bays. Sam and Scott reported that they have identified trees that should be removed and have received a bid.

5. Follow on Karen's suggestion about adding cameras in the action bays. After discussion, the committee felt that it would not be cost effective and Glenn would not be able to leave the rifle range unless he had another worker with him. Glenn can see the action bay parking lot and we would like to have him monitor the lot and compare the number of vehicles to the number of people who have signed in. Example: one person signs in but he sees three cars in the lot. He still can't walk over and check unless he has another worker with him to cover the rifle range...

Steve Traverso took that action to provide a cost estimate

- 6. Keeping the brass and steel picked up The committee suggested the following: post and announce that members may pick up and keep brass that they find in the action bays. They must check in with Glenn each time. A sign should be posted.
- 7. RSO II Recertification. Committee suggestion: Scott is completing a list of SO II's and any person who was approved to use the bays prior to the last rules update (11-1-2018) will be contacted via email and asked to attend an orientation before their membership expires in 2020. The orientation will follow the same process that we do today (meet in the bays, review the rules and ask a few questions). This will ensure that everyone is up to date on the current rules. The orientations can also take place after a disciplines monthly match. RSOII's will not lose their certification until this process has run for a few months.

#### **New Business:**

- 1. Martha who is a Bi-Athlete asked about conducting an information sessions on the sport. The board was supportive of her conducting the sessions.
- 2. By-law amendment change (First Reading).

Reason the amendment change. Due to low eligibility to voting (19 & 22 the last two years) and I have seen life members not able to vote due to not attending required meetings, therefore I am submitting this amendment change to the bi-laws. I feel that Life members have paid their dues to RF&G club and have earn this right, are informed and up to date on the operation of the club and want the club to continue to function, the same goes for our full-time employees.

Amendment Changes to read as follows, (changes are added in bold print and underlined).

ARTICLE V: Election of Directors and Officers

Section 5. All full members must have attended at least two (2) Board or membership meetings in the previous eleven (11) months to be eligible to vote on amendments to the by-laws, or to vote in the annual election of officers. <u>Exception, All RF&G Club Life Members along with full time</u> employees, will have full voting rights without the two required meetings.

3. Rob Potter has 3 "Texas Star" targets for sale at \$600 each. The plates are not on a hinge, so they do fall to the ground when hit. This type of target is particularly used in Cowboy Action Shooting, can be used in USPSA. It's AR500 & is Rifle Proof (has been used with 5.56x45's) is illegal in IDPA.

The club is not interested at this time.

- 4. Safety Items for September
  - a. Ted pointed out that the upper pedestrian gates be checked out and possibly closed off. Sam will follow up.
  - b. Additional DOSH Lead Rulemaking Stakeholder Meetings September 2019 (this should only apply to indoor ranges).
