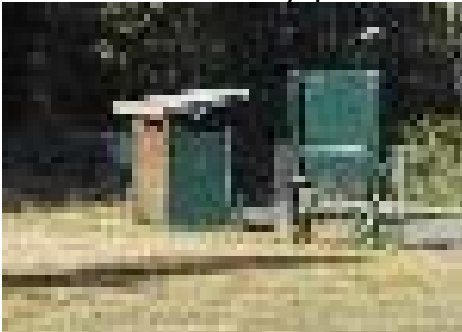
Reported that said they had 48 shooters at the September Match.
