2022 Season Report

- Thank you! Renton Fish and Game, for supporting our shooters for another season.
- <u>Team:</u> 15 shooters, 3 "recreational" shooters who only practiced and 12 shooters who competed in two or more tournaments, 3 registered coaches.
- We participated in the following tournaments:
 - Sporting Clays event, Gervais Oregon (hosted by the MidValley Crushers)
 - Won 5 awards, 3rd HOA squad, and 4 individual awards.
 - Lower Columbia Challenge (hosted by Woodland Trap Team)
 - 9 Medals, 2 individual HOAs, 7 event trophies, 3 personal bests.
 - Clays for Days (hosted by Midvalley Crushers)
 - 3rd place team HOA, 6 individual medals.
 - Shotgun challenge (hosted by SST)
 - 3rd place team HOA, 8 individual medals, 2 personal bests.
 - o Jr. Yak, (hosted by the Selah Claybusters)
 - 1st HOA sporting Clays, 2nd HOA all other events, 5 individual medals, including one first time medalist (Sofie Cannon), 4 individual medals.
 - WA Youth State
 - 2nd HOA team, 9 individual medals and 3 squad awards, 6 personal bests
 - Northwest Open (hosted by Whatcom Claybusters)
 - Swept every HOA and event, 13 individuals medals, one first time medalist (Roman).
 - Nationals, San Antonio Texas (sent 6 shooters, thank you for your \$\$ support!)

We are taking 18 kids, 10 boys and 8 girls, to participate in a field of 2200 entries. The best youth action shooters from across the country will be attending and we are excited to shoot in the bays with them. Clearly, it's a challenging environment, but our kids have been working hard and are ready to give their best performance. We compete in squads of 4, so to do well each athlete in the squad needs to be on their best game.

Nationals is the culmination of our primary spring and summer season, and our kids are very excited to be able to participate. Much thanks to everyone at RFGC and the Youth Committee. You give significant resources of time and money to support these kids. The kids are very appreciative, and they're hopeful to bring back some place finishes to demonstrate their efforts and capabilities on the national stage. And while everyone loves the hardware, we all know there's a much bigger value for the kids in programs such as this.

We had 35 shooters over the two days (June 4th & 5th), 24 on Saturday and 11 on Sunday, four were comped. There were no DQ's either day.

Here is the report for our matches on July 2nd & 3rd:

The range was in good shape when we arrived on Friday afternoon to set-up the match. Carlsbad Kid (Karl Mayer), and J. J. Wainwright (Darin Puryear) came out to wrangle the steel and props to set six bays! My thanks to them both.

The Steel Dragons used bays one and seven for their practice while we set the other five stages in bays 2 through six and were finishing with their last shooter in bay one at about the same time, we were ready to roll in and get that one set. Thanks to them for their cooperation.

Saturday was cloudy but dry, and we had 25 folks come out to play our game, including two new shooters to our club.

Two shooters managed to shoot the whole match clean, Lawbreaker (Tim Thibert) and Carlsbad Kid (Karl Mayer). Carlsbad even managed to do it shooting black powder! Nice going gents.

Our top three competitors this day were: G. D. Rattler (Bill Hanson) in third place, Diamond Slinger (Matt Randolph) in Second, and Lawbreaker coming in first. There was one Stage DQ for a dropped, unloaded gun on the line, but no other safety concerns or violations.

Sunday's weather was not so summer-like for us as we had rain all day! Nine intrepid (crazy?) cowpards came out anyway to slay the steel bad guys.

No one managed a clean match on this day, but our top three shooters were: Cedar County Sheriff (Derek Mirkle) in third place, Buffalo Belle (Anna McDermott) in second, and Jus Nobody (Barry Turner) in first. There were no DQ's or safety issues.

\$290.00 was turned into the Club.

Our next match will be our annual match, WESTMATCH XXXI, August 5th through the 7th.

Civilian Marksmanship Program (CMP), Don Miller:

1. Action bay upper berm repair, on top of bays 4 and 5 (LaMarr).

Status: Complete

2. The facing on the North side of the club house needs repaired and painted (LaMarr).

Status: Complete

3. New cover for Godzilla (LaMarr).

4. Dave asked if Roy could provide electricity to the Wi-Fi transmitters in the action bays.

Status: Will be delayed for a few months.

 Come up with a plan to establish a volunteer RO program, to include requirements of volunteers, limits of authority and any discounts to membership. Karen Status: In work.

6. New financial and membership system for the club – Georgia Status: On hold until all the issues are resolved with QuickBooks. No Change until I can get more time off work

- 7. John Palmer: Labor & Industries visit. L&I provided an industrial hygiene consultation report letter and sample safety programs templates we can use as a reference to update our programs. *Status: In work.*
- 8. Addressing issues on the Pistol Range (baffle replacement, a new short berm in front of the 10-yard target stands (similar to what is in front of the 25-yard targets) and adding angled steel plate to the baffles (as is done at indoor ranges) LaMarr Status: Mark, Scott and LaMarr met to look at the area. There are three different sizes of target holders. Mark is going to look for 3/8" AR500 Steel for the safety areas.
- 9. Ted is looking at other options for catching the shot (current cloth is not working) on the shotgun range.

Status: Will be putting out a sample on Monday

10. Karen – The referendum regarding the high-capacity magazine ban.

Status: No update

11. Dave - WIFI at the range.

Status: Signed a month-to-month contract with T-Mobile and is waiting for the router to arrive

12. Mike Beck - Trophy case for the Crushers.

Status: Still following up, the one that was offered for donation wasn't suitable for the space (more beat up than expected), but is continuing to find one to put in place next to the TV, will share pictures when available, this will be no cost to the club

New Business:

- 1. Safety Items for June:
 - a. Martha Bellisle reported and addressed two safety violations at the rifle and pistol range on Friday, June 10.

A man and woman were standing in front of an open trunk in the parking lot. She had a handgun in her hand, a loaded magazine was lying about a foot away and he was telling her how to hold it.

While preparing for a cease fire on the pistol range one person's handgun was loaded and had a round in the chamber.

- 2. Mike Beck request: #8 Shot on the Skeet range. As getting #9 shot continues to be a problem, we would like to get formal approval to shoot #8s on the skeet range (1145-1250 FPS). The desk has blocked some of our shooters from practicing with team ammo (we get it, the rule is the rule). We're suggesting before next season we modify the policy to allow practicing with #8s, < 1250 fps until we see a significant change in the shell market. MSP: to allow #8 shot on the skeet range</p>
- 3. The donation committee voted to award \$5,400.00 to the Steel Dragons for their competition
- 4. Marcel is requesting the purchase of 7 trauma (stop the bleed) kits for the action bays. It was suggested that the Steel Dragons also purchase 4 kits.

Todd Vasko has a connection that may be able to teach a stop the bleed class.

MSP: to purchase 11 trauma kits

- 5. Ted will be ordering a new electric pallet jack to store targets in the new building.
- 6. Discussion regarding purchasing a UTV for the range / action bays.
- 7. Request to allow discipline heads and their associated staff, free or discounted memberships. Will be addressed at a directors meeting.
