Friday afternoon found the range in fairly good shape, although soggy. It was decided to move the stages back to the north bays, as the south bays were already pretty muddy, and the forecast was for a lot of rain for the weekend.

Saturday saw us arriving to find that the winds had blown over the portable rain shelters in bays 1 & 3, but neither were damaged, and easily righted.

We had 24 intrepid adventurers come out for the "Jed I Knight Tribute" match. Jed I is a (now) local shooter who has a fairly well-known YouTube channel called, strangely enough, Jed iTV. He has provided great exposure to most of the local SASS clubs in our area, since moving here a couple of years ago.

The weather was much better than predicted and we managed to stay dry for the whole match, and the Sun even peeked out a couple of times.

There was but one shooter that managed to shoot the match clean on this day, R. P. Dodge (Richard Otto), Our top three cowboys were: Mudflat Mike (Mike Perin) third, T-Bone Shorty (Terry Sporrong) second and R.P. Dodge first overall. There was one stage DQ for moving with a cocked loaded gun, but no other safety violations.

Sunday, 13 folks arrived to a fairly steady rainfall, but it subsided fairly soon after we started the match and stayed dry the rest of the match. Two shooters cleaned the six stages, they were, Appy Dan (Dan Glor) and Bjorn E. Ville (Eric Simonson). Our top three shooters were: Appy Dan third, Jed I Knight (Rick Bell) second, and Bjorn E. Ville First. There was one Stage DQ for putting a gun down with a live round in the chamber and losing control (taking hands off) the gun. No other safety concerns for this day.

\$330.00 was turned into the club. Our next matches will be Dec. 3rd & 4th.

Steel Target Qualification and Procedures:

The steel target at 200 yards may only be used by members who have qualified (their badges will have a star punched in it).

To qualify the shooter must coordinate with the Rangemaster and shoot a consecutive fiveshot group on an eight-inch target at 200 yards.

The steel is checked out by the shooter (see sign-in/out sheets) and when finished must be checked back in to rangemaster. Targets must be re-painted and any repairs done. If repairs are beyond reasonable fixes, shooter must alert rangemaster to issues.

When shooting steel with new firearm (unqualified firearm), shooter should put up paper target at 200 yd and confirm where firearm is hitting BEFORE shooting steel. Steel is NOT intended to be used as a sight-in tool.

Other qualified shooters may use steel at the discretion and approval of the shooter who originally checked the steel out. They have the right to refuse other qualified shooters to use the steel at the same time. If they allow other qualified shooters to use the steel, and original shooter cannot/does not bring steel back in, they must inform rangemaster they are turning the steel over to the responsibility of the other shooter and sign steel out of their name and into the name of the other shooter.

All qualified shooters are responsible for watching who is shooting the steel and stopping non-qualified shooters from using the steel. If non-qualified shooters refuse to stop, alert rangemaster and they will talk to the non-qualified shooter and explain the rules of shooting the steel target.

If steel is checked out but will not be checked back in until after 6pm, shooter must return key to rangemaster before 6pm. Shooters may NOT check out steel after 6pm.

Failure to follow these rules may result in the loss of steel target privileges.

New Business:

- 1. Safety Items for November:
 - a. On November 20th it was reported that shot from the skeet range was coming through gaps in the wall and hit a shooter in bay three (there were no injuries). Ted took the action to look at the wall. The Monday crew will fix it.
 - b. We always need people to help clearing the snow. There is also ice melt that can be used.
- 2. Robb requested approval from the Board to purchase three covers for the action bays.

We would like to put them in Bays 1, 4 & 7. If they work out well, we will consider purchasing more. But those bays currently need them the most.

This is the same company that we purchased the cover for the clays from. His covers are good quality, and they are less than other companies like "Canopies & Tarps". Their cover was \$2K but did not include shipping, tax, or assembly.

Covers are 12' wide x 20' long x 7' sides with roof only.

Price each would be \$2,050.00 x 3 = \$6,150.00

Discounted price would be \$5,335.00 + Tax.
