**MSP** to allow the class (pending approval of the instructors' information) on March 28-31, 2024. Using bays 1 & 3.

I am requesting the Board's permission to host Ben Stoeger Classes at Renton Fish & Game March 28-31, 2024. The classes will be roughly 9am to 5pm each day. Ben is a national and world champion in USPSA, and the classes are for learning USPSA skills. Ben will run two separate classes, a Fundamentals class for two days, and then a Skills & Drills class for two days. Each class will have a total of 12 students, so 24 students total over the four days.

The dates I am requesting won't interfere with the club's USPSA match schedule since those are typically the 4th Sunday of the month. The class would only require the use of two action bays for all four days, so other members can still access the other 5 action bays during class time. The rifle and pistol bays won't be affected either.

A good majority of the students will be club members or local to Washington state. We will have our own targets and pasters, so the only use of club property will be the stage props and target stands. Club members will be watching the club property when we break for lunch.

Safety is always the primary concern. We will make sure every round impacts a berm, while observing the 180. Ben also has a 2 million dollar insurance policy. Ben teaches professionally, and is already booked out until next year, which is why I am requesting this so early.
